### **CONDITIONS, RULES AND REGULATIONS FOR THE**

#### **R. E. Brislawn Spanish Mustang Promotional Fund**

##### **The Award**

The Award is given in support of the efforts by SMR members to community, country, and the world in the use of SMR registered horses. The cash award is given in January as a single payment.

##### **Eligibility and Qualifications**

To be eligible, the applicant must be an SMR member of good standing (dues paid and up to date). Completed applications must be received by December 1. To qualify for the award, which is judged on the merit of the application, the applicant must demonstrate the following:

1. **Dependability** – Applicant must have executed responsibilities with honesty, loyalty and reliability. Applicant must exclusively use SMR registered horses in the “event”.
2. **Leadership** – Applicant must have demonstrated ability to lead with self-control, dignity and responsibility. Applicant must introduce the SMR registered horses to the public in a positive manner.
3. **Clear Sense of Purpose** – Applicant must have pursued his/her goals and commitments with sincerity and integrity.

##### **Other Requirements**

Applicant must complete this official application or a facsimile, which then becomes the property of The Spanish Mustang Registry, Inc. Previous winners are ineligible.

Completed applications must be received by December 1.
